#### YouWeCan's Rapid Response Solution for Critical Care Capacity Expansion in Government Hospitals

The second wave of the COVID-19 pandemic was traumatizing for people across India and it has left an indelible mark on everyone's hearts and souls. Due to issues like lack of adequate healthcare infrastructure and human resources, people residing in both rural and urban areas of the country had to go through immense grief wherein even to bid the final farewell to one's loved ones who succumbed to Coronavirus became an act of privilege.

With the onset of the COVID-19 pandemic in the year 2020, the YouWeCan Foundation sprang into immediate action and mobilized over a million hygiene kits to 16 state governments across the country, in collaboration with reputed organizations such as PAYTM and Lifebuoy.

We also worked closely with the Ministry of Health and Family Welfare, United Nations Children's Fund (UNICEF) and World Health Organization (WHO) on multiple COVID-19 awareness campaigns throughout the year.

As 2021 commenced, the situation started improving and hence people put their guards down and became less vigilant. This proved to be a big mistake because of which we were hit by the second wave of the pandemic. The intensity of the new variant took everyone by surprise and it was rare to find a household in India that was unaffected by the wrath of the second wave of COVID-19. As a result, hospitals across the country were flooded with patients struggling to find beds and gasping for oxygen support.

Our Founder Mr. Yuvraj Singh realized the need of the hour and came up with the 'Mission 1000 Beds' as a hospital capacity augmentation program for COVID-19 Critical Care. The project aimed at mobilizing urgent support with the intent of saving many more lives.

It has been a rapid response project with an average turnaround time of 15 days from the receipt of grant till complete installation and handover of the set up to the hospital.

The project was executed effortlessly by our teams that worked 24x7 tirelessly with on-ground support from our volunteers under the guidance of the Project Steering Committee.

### **#MISSION1000BEDS** IMPACT

We reached out to Government Medical Colleges, Army Hospitals & Charitable Hospitals to increase the capacity of COVID-19 critical care beds by about 10% of the existing capacity. The setup included 100% oxygenated beds equipped with 50% BiPAP support and 10% ventilatory support along with additional essential equipment.



### PAINTING THE COUNTRY **BLUE**

The Mission 1000 Beds initiative was started in June 2021 and it gained momentum rapidly, with requests for beds and medical equipment pouring in from all parts of the country. After due diligence, the Foundation partnered with 14 Government hospitals across 11 states to increase their critical care capacity.



## **CANCER OF WOMEN**

Around the world, cancer affects more men than women. However, this trend is reversed in India. Research on why women in India have a higher incidence rate of cancer is yet to yield definite results. It also suggests that while cancer does hit more men than women, women are better equipped to fight the disease.



In 2018 alone, the number of new cancer cases in India stood at 11.57 lakhs. And while the country's cancer burden continues to see an uptick, a particularly dismaying trend is the disease's influence on women. According to recent reports, cancer is impacting more women than men in the country. Women cancer cases then constitute over 55% of the country's total cancer cases!

According to Globocan 2018, women are most affected by

breast, cervix, uteri, ovary, lip/oral cavity, and colorectal cancer. Breast cancer alone makes up 27.7% of the total cancer cases in women, followed by cervix uteri (16.5%) and ovarian cancer (6.2%). At 45-50 years, the average age for breast cancer in India is almost a decade lower than that in the west where the average age for the onset of breast and ovarian cancer is 60 years. This trend is partly attributed to genetic and environmental factors that persist in high-income economies.



## **BREAST CANCER**

Indian women live with the most significant number of health-related problems, and paradoxically with the least number of systemic approaches to tackle them.

## In India, 1 woman is diagnosed with breast cancer every 3 minutes, and every 6 minutes, a woman dies of breast cancer.

Early diagnosis of breast cancer accounts for only 30% of all reported cases in India, compared to 70% in the developed world. Since 70% of patients are diagnosed with cancer when the disease is far too advanced (stage 3 or 4), the mortality rate is very high. It is estimated that the fiveyear survival rate decreases by 2.7 times for breast cancer when it is detected at stage IV as against stage I. Similarly, treatment cost for late-stage cancers is 1.5 to 2 times higher than for early-stage cancers. Late-stage presentation is precipitated by two major factors - the absence of proper breast cancer screening programs, and the nonparticipation of patients in such programs if they exist. There are a number of reasons behind this - unawareness, lack of access to quality healthcare facilities, and socio-cultural attitudes. For a screening program to be successful, the coverage and participation have to be high, and the referral system for the diagnosis and treatment has to be effective.

With the understanding of the epidemiology of the disease as well as the Indian scenario, it makes sense to attack the impediments in battling the disease in a sustainable approach that educates women vulnerable to the disease on the disease and prevention and makes breast cancer

### OUR APPROACH Educate-Detect-Empower

screening available, accessible and affordable. By making new-age AI-powered theramlytix technology available and affordable, we are making breast cancer screening a painless, non-invasive, and radiation-free experience for the women in the country who still find talking about their breast health a major taboo.



- To deal with the taboo, education, and awareness will play an important role in enabling behavior change and motivating women to conduct self-breast exams and also undergo screening to be aware of their breast health. This step is crucial to understand the underlying social determinants that might be hindering women to prioritize their health and address them.
- When more women are informed about their health, they will access health services that they trust and don't invade their privacy. Higher coverage of women that are screened allows for better risk assessment, early detection, and evidence generation for future research.
- The final step is to empower the community to link them to the treatment services offered and offer them last-mile support through follow-ups and counseling.



### OBJECTIVES OF THE PROGRAM

- 1. Free breast cancer screening of 10,00,000 women in India across 5 states by 2027, ensuring 50% of the age-eligible population is screened.
- 2. Raise awareness and educate all target populations on the risks and prevention of breast cancer and self-breast examination.
- 3. Ensure early detection and link beneficiaries to timely treatment services for breast cancer.
- 4. Strengthen the existing preventative strategy by providing the latest innovative health intervention in the Indian context, for breast cancer screening.
- 5. Enable strong partnerships with the Government and private stakeholders to strengthen the National Cancer Control Programme in India.

We value female lives and aim to reach out to every eligible female in the country and change how we tackle the big C that is Cancer today.

## SWASTH MAHILA SWASTH GOA INITIATIVE



In association with SBI Foundation and Government of Goa, we launched one of its kind project for screening 1 lakh women in the state of Goa for the most common cancer amongst females in India - Breast Cancer, thereby ensuring that 50% of the age eligible female population in the state is screened using an innovative radiation-free, ultra-portable wireless device, usable by lay health-workers to identify and document small, non-palpable lumps, quickly and easily, at the point-ofcare.

The initiative was launched on 26th October 2022 at the Goa Medical College by Shri Vishwajit P. Rane, Minister of Health, Woman &; Child Development, Skill Development &; Entrepreneurship, and Industries, Trade &; Commerce, Government of Goa. Other key dignitaries who were present on this occasion included Smt. Shabnam Singh, Chairperson, YouWeCan Foundation; Smt. Manjula Kalyanasundaram, Managing Director, SBI Foundation; Dr. Ira Almeida, Director Health Services, Govt. of Goa; Prof. Dr. S. M. Bandekar, Dean, Goa Medical College; Shri. Sudhir M Galande,Deputy Chief Executive Officer, Indian Institute of Banking & Finance; and Shri Bhaumik Sanghvi, Co-Founder & COO, UE Life Sciences.







A 11-member team has been conducting multiple outreach activities and screening camps across the state.

Multiple sessions have been conducted for the training and capacity building of the primary healthcare professionals of the Government of Goa to screen women for breast cancer using the device.

The initiative doesn't just aim to screen the beneficiaries but ensures free treatment for all positive cases with the support of the Government of Goa and thorough emotional support is provided by our team.







## PEDIATRIC CANCER

Over the past two decades, India has significantly improved its services for children with cancer. However, as compared to international norms, the outcome is still modest because there are major obstacles to recognition, diagnosis, and treatment.

In India, there are only a select few tertiary care facilities in the country's largest cities that offer pediatric cancer services. Major cancer groups' outcomes are hampered by delayed and more advanced stages of presentation, poor supporting care during rigorous therapy, and other factors. Major obstacles still include treatment refusal and abandonment.

For the kind and severity of the condition, a proper diagnosis is necessary in order to recommend the right course of treatment. Chemotherapy, surgery, and/ or radiotherapy are examples of common treatments. Children also require specialized care for their ongoing physical and cognitive development as well as their nutritional state, which calls for a committed, multidisciplinary team. Around the world, there exist disparities and uneven access to accurate diagnosis, necessary medications, pathology, blood products, radiation therapy, technology, and psychological and supportive care.

## CANCER TREATMENT FUND



The YouWeCan Cancer Treatment Fund for Paediatric Patients offers financial support for the treatment of qualified cancer patients, up to a cap of Rs. 2,000,000.00 (two lakhs) per patient. Only patients from disadvantaged backgrounds who are younger than 16 are qualified to receive assistance from the fund.

According to the hospital's treatment plan, all medical expenses for the shortlisted patients are covered, including (but not limited to) diagnostic testing, investigations, chemotherapy, radiation therapy, surgery, and prescription drug costs. The partner hospital offers all medical services directly associated with the treatment. YouWeCan Foundation's role is limited to providing financial aid to support the cost of treatment.

Strict processes are in place for due diligence and screening of cases. To ensure transparency and to maintain strong financial control, funds are disbursed directly to hospitals and not to beneficiaries or their caregivers/ family.



## YWC SCHOLARSHIP FOR CANCER SURVIVORS






Education plays a significant role in predicting future employment, income, and integration into society in general. As a result, education level may be regarded as a crucial indicator of the effectiveness of long-term survivability. Along with the potential effects of treatment on cognition, skipping school due to treatment and falling behind in academics might have a negative impact on survivors' ability to complete their education. According to some research, 50% of kids with cancer go to school in the first month after treatment begins. This rises to 70% of kids in the fourth month after treatment begins, but absenteeism is higher in kids with brain tumours than it is in kids with other cancers. Irregular school attendance has been reported to last years after the end of treatment, adding to the educational difficulties experienced by survivors.

The YouWeCan Scholarship provides financial assistance to cancer survivor children from marginalised backgrounds, to help them get reintegrated into the formal education system, once their cancer treatment has been completed. Once a student has been enrolled for the program, they are provided a scholarship of upto Rs. 20,000.00 per year. Moreover, they are supported on a year-on-year basis, every year till the time they complete their education.

The Scholarship Program was started in 2016 after Yuvraj observed that a large of young cancer survivors from underprivileged backgrounds, between the age of 5 and 16, were dropping out of school after completing their treatment. Although there were many reasons behind this, the primary reason was due to financial constraints. Initially, the scholarship was restricted to school students only, but in 2018 the criteria was changed to include cancer survivors pursuing their higher studies as well.



## **STORIES OF HOPE** YWC Cancer Treatment Fund #CancerWarriors

### **Anvesha Singh**

Anvesha was diagnosed with OsteoSarcoma and was on the point of having her legs amputated. Her condition was quite critical, and the expense of the treatment was high.

The social workers at the hospital where Anvesha was receiving care introduced her parents to the Yuvraj Singh Foundation after they had given up all hope that they would be able to pay for the cost of her care.

YSF escalated their processes in lieu of the situation and provided Rs 4,00,000 to support Anvesha's treatment, which was completed without an amputation. Anvesha is the real definition of fortitude and tenacity. Anvesha's unwavering determination to accomplish her life's ambitions was unaffected by cancer.





### **Parth Parag Nair**

Parth is a cheerful 9-year-old boy who enjoys going to school, making friends, and working hard. At the age of 3 years, he was diagnosed with blood cancer (acute lymphoblastic leukaemia). Parth's parents applied for financial support under the YWC Cancer Treatment Fund and were provided a grant of Rs. 2,50,000.00 to support his treatment.

Post treatment, Parth's parents were finding it extremely difficult to meet day to day expenses including the cost of his education as they had exhausted all their savings during his treatment.

Seeing the family's situation, YouWeCan's social workers reached out to the family and Parth was awarded a scholarship of Rs. 25,000 per year to cover his educational expenses.

Today Parth is a confident young child studying in the 4th grade. We are determined to support thousands of other cancer champions just like him and ensure they complete their education after cancer.

### Tanya

I am an assistant makeup artist and my husband used to work on a poultry farm.

She always used to complain that she is feeling fatigued and she is not feeling well. She used to sleep very early due to her tiredness. Whenever we used to visit the doctor he always used to say that it's just weakness tell her to have proper nutritional food etc. but, in October 2021 she started having some infection in her eye and some unwanted parts started growing near her eye. Then I came to know that her left eye's vision is very less. We went to the physician nearby and he suggested MRI when a report came we came to know that she is suffering from Orbital Rhabdomyosarcoma.

It was very devastating for us as her parents because her daughter is suffering from cancer at such a young age. It felt like I have lost everything. The family members and friends consoled us that





### Shiva

Shiva's father is in transport business and his mother is a housewife. They are 7 members in the family. He was alright till the age of 3 years but after that he started having fever after every few days. He stopped walking as she started having issues in his legs. Doctor told us to get him tested and after the test we came to know that he is suffering from a particular type of blood cancer. After a lot of medications also he was not able to get well his fever was increasing day by day. We admitted him to PGICH, Noida. There doctor removed water from his bones and then he started feeling better.

The current situation of the child is fine. He is doing good, and his healing process is going on well.


No, currently he is not studying as he is just 4.5 years old. He is too young to have dreams and aspirations but as a mother I hope and wish best for his future.


Currently his hobbies are just to watch cartoon and to play with toys.

Syed Asad aged 4, belongs from a remote village located in Putki Block of Jharkhand. After observing distinct changes in the daily activities of Asad, the parents got extremely concerned about the overall health of their son. On the suggestion of the local doctor of the village, Asad was taken to Muskan Hospital and Research Centre. The senior doctors of the Pediatric department referred them to the department of Haematology. The family with their limited income borrowed money from their distant relatives and friends to bear the cost of the blood test required to determine the diagnosis of Asad. The result confirmed that Asad was suffering from Acute Lymphoblastic Leukemia – a type of blood cancer. Asad was referred to Tata Medical Centre Kolkata which gave the family an estimated cost of treatment of approximately Rs 6,00,000. The family had an annual income of Rs 48000 and was not in panic and





### Tanuj

Hi! I am Tanuj and I am a cancer survivor. I think if you have to beat cancer you have to learn to bear the pain. I was diagnosed 4 years ago. I used to feel very claustrophobic and had a lump in my neck. No matter the challenge I face – I tell my mother. When I did, she took me to the doctors, who confirmed in 2016 - that I was suffering from cancer. We traveled from Hisar to AIIMS Delhi and every day was a new challenge for me. I was going through chemotherapy. It was a very difficult time for me and my family. I thought of breaking all shackles and running away. I used to feel like my body is burning. But giving up was not an option. I chose to fight cancer and began to come out of it. I am now happy and cheerful, and can finally follow a regular routine. I want to become an artist and my parents are supporting my journey towards achieving my dreams. My mom thanks the YouWeCan foundation and Mr. Yuvraj Singh as they have helped us a lot. YouWeCan is supporting my education till the 12th standard, in addition to their assistance through such a difficult time. When you have a strong support system, you can overcome anything!


